#### ACCESSIBILITY COMPLIANCE STATEMENT

## 3. Level of Compliance

The Company declares that its digital interfaces related to its products and services – including its website, online customer service systems, electronic invoicing, and administration functions – have been developed and evaluated in accordance with the general and specific accessibility requirements defined in Annex 1 of the Act.

The compliance review covered the following areas:

- Machine readability of website content and compatibility with screen reader software
- Adjustable contrast ratios and text sizes
- Full keyboard navigation support without requiring a mouse
- Alternative access to visual and auditory content (e.g., captions, screen reading options)
- Logically structured, consistent navigation and user-friendly accessible interface
- Accessible error handling, forms, and user feedback mechanisms

The self-assessment and related development measures were based on the WCAG 2.1 (Web Content Accessibility Guidelines) AA compliance level, in line with relevant legal and professional standards. The Company is continuously working to fully comply with all accessibility requirements.

#### 4. Feedback and Reporting Issues
